PROFESSIONAL BIOGRAPHY

Dr. Celvin G. Walwyn is a career law enforcement executive with nearly four decades of command-level service spanning sovereign national police forces, the federal territory of the U.S. Virgin Islands, and the State of Texas. He is the Founder and Executive Director of Integrity Assessments Investigations (IAI), a licensed Texas private investigations firm serving criminal defense practitioners in the Southern District of Texas and surrounding state courts.

Dr. Walwyn has served as Commissioner of Police of a sovereign Caribbean nation — the highest policing authority in that jurisdiction — as well as Deputy Commissioner of Police for Operations with the United States Virgin Islands Police Department, where he held command authority over all operational law enforcement functions. He retired from his position as a Texas Police Chief in 2026 after nearly four decades of command-level service.

He holds a Doctor of Philosophy (Ph.D.) in Public Safety from a nationally accredited institution, with a research specialization in Police Leadership. He is a certified EyeDetect Examiner and is trained in Post-Conviction Sex Offender Testing (PCSOT). His academic and professional credentials position IAI as a uniquely qualified investigative resource for defense counsel navigating complex federal and state criminal matters.
